- 1 15<sup>th</sup> October to 10<sup>th</sup> November
- 2 26<sup>th</sup> December to 31<sup>st</sup> December
- 3 On the first day of the Chinese New Year and the 3 days immediately preceding it.  
Next Chinese New Year is 23<sup>rd</sup> January 2012.
- 4 On the day of Diwali (Hindu New Year) and the 3 days immediately preceding it.
