  - Certificate of Insurance. If the certificate is a cover note then the full policy must be produced at the Taxi Licensing Office when the applicant receives it.
  
- 2) If your application is for a new vehicle, change of vehicle or additional vehicle, the following documentation must be produced:
  - Purchase receipt. **(NOTE: the name on the registration document is the recorded keeper of the vehicle. THE REGISTERED KEEPER IS NOT NECESSARILY THE LEGAL OWNER).**
  - Certificate of Insurance. If the certificate is a cover note then the full policy must be produced at the Licensing Office when the applicant receives it.

**NOTE: The information given in this form will be put onto a computer system registered under the Data Protection Act 1984 and may be used by Blackpool Borough Council for the prevention and detection of Fraud.**
