

NOTICE OF CONFIRMATION OF PUBLIC PATH DIVERSION ORDER

TOWN AND COUNTRY PLANNING ACT 1990
SECTION 257 AND PARAGRAPH 7 OF SCHEDULE 14

THE BOROUGH OF BLACKPOOL - PUBLIC FOOTPATH N° 23

DIVERSION ORDER N° 1 2000

On the 13th day of April 2000 Blackpool Borough Council confirmed the abovenamed order (hereinafter referred to as "the Order") without modification as an unopposed order.

The effect of the Order as confirmed is to divert Public footpath number 23 on the Definitive Map, which runs from Low Moor Road to the Southern side of Carleton Cemetery, joining the Cemetery driveway near Poulton le Fylde boundary. An alternative footpath will be created as specified in the Order.

A copy of the Order as confirmed and map has been deposited at the office of the Chief Executive, Town Hall, Blackpool and may be inspected free of charge Monday to Friday between the hours of 9.00 am and 4.30 pm. Copies of the Order and map may be purchased.

This Order shall have effect on the date on which it is certified by Blackpool Borough Council that the terms of Article 2 of the Order have been complied with.

Any person aggrieved by the Order who desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above-mentioned Act, or on the ground that any requirement of that Act or any regulations made under it has not been complied with in relation to the Confirmation of the Order, he or she may apply to the High Court for any of these purposes under Section 287 of the Town and Country Planning Act 1990, within 6 weeks from the date on which Notice is first published in accordance with the requirements of paragraph 7 of Schedule 14 to that Act.

DIVERSION ORDER NO 1 2000

The above-named order (hereinafter referred to as "the Order") made on the 10th February 2000 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Blackpool Borough Council as an unopposed order.

The effect of the Order if confirmed without modification will be to divert Public Footpath number 23 on the Definitive Map which runs from Low Moor Road to the southern side of Carleton Cemetery joining cemetery driveway near Poulton-le-Fylde boundary. An alternative footpath will be created as specified in the Order.

A copy of the Order and the map contained in it has been deposited at the office of the Chief Executive, Town Hall, Blackpool and may be inspected free of charge Monday to Friday between the hours of 9.00 a.m. and 4.30 p.m. Copies of the Order and map may be purchased.

Any representations or objections with respect to the Order may be sent or delivered in writing addressed to the Chief Executive at the Town Hall not later than 16th March 2000. Please state the grounds on which such representations or objections are made.

If no representations or objections are duly made, or if any so made are withdrawn, the Blackpool Borough Council may itself confirm the Order as an unopposed order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which may have been duly made and not withdrawn will be sent with the Order.

Existing Definitive Statement

Leading from footpath 23 in a northerly direction for 175 metres and in a north-westerly direction for 168 metres to Moor Park Avenue.

Proposed Statement

Leading from footpath 23 in a northerly direction for 287 metres, then in a north-easterly direction for 88 metres to Tarragon Drive, proceeding along footway of Tarragon Drive in a northerly direction for 50 metres and then along footway of Moor Park Avenue in a westerly direction for 105 metres.

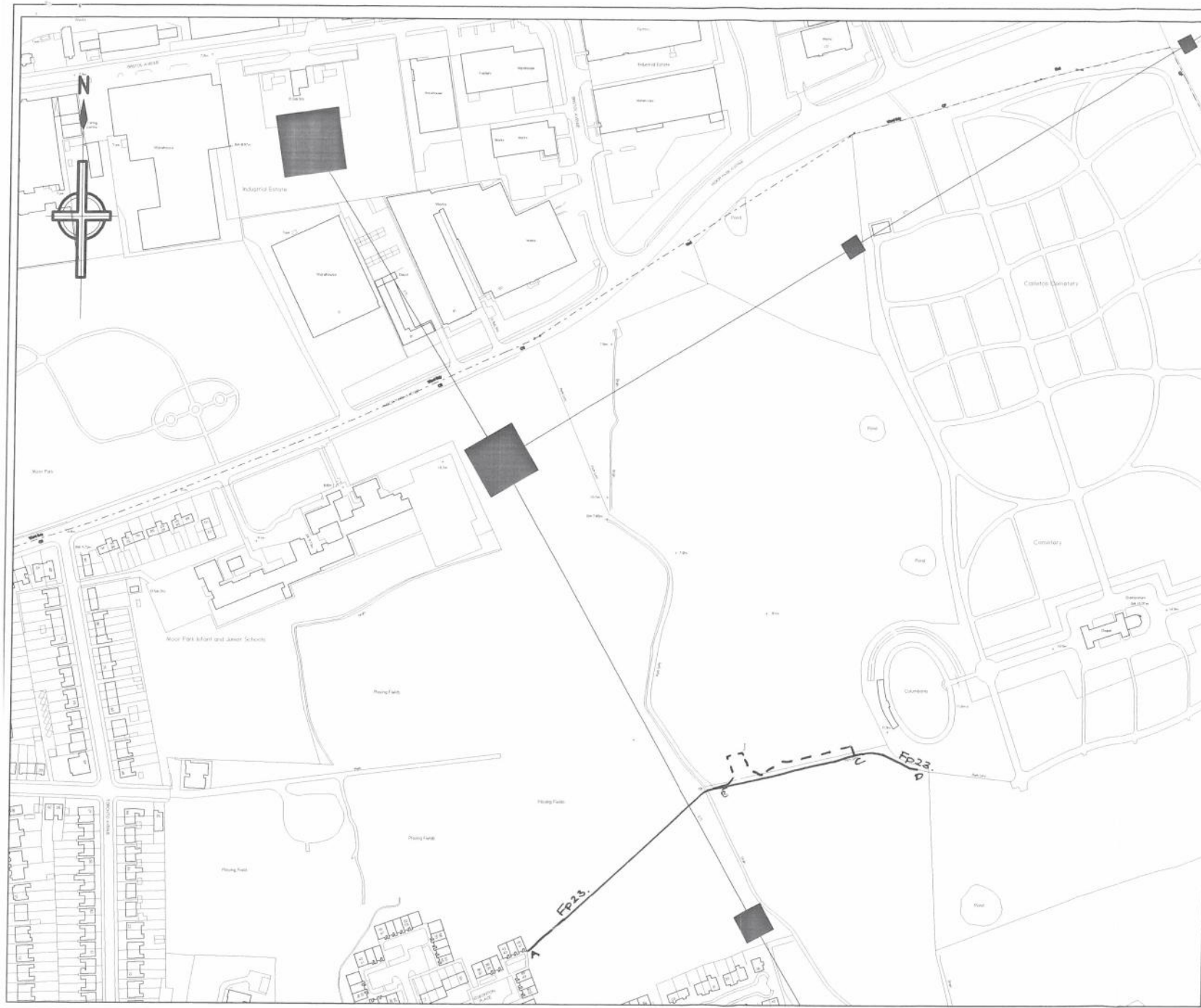
Existing Definitive Statement


Leading from Low Moor Road in a north-westerly direction to footpath 38 and then in an easterly direction to the southern side of Carleton Cemetery to join cemetery driveway near Poulton-le-Fylde boundary.

Proposed Statement

Leading from Low Moor Road in a north-westerly direction to footpath 38 and then in an easterly direction proceeding along footway of Sage Close, across Corriander Close and along footway of Corriander Close for 99 metres to the southern side of Carleton Cemetery to join cemetery driveway near Poulton-le-Fylde boundary.
