If any person to whom a petroleum spirit licence is granted contravenes any condition of the licence, they shall be guilty of an offence as per Section 1(3) Petroleum (Consolidation) Act 1928.
3. The Licence or a copy of the licence must be kept on the licensed premises.
4. It is a contravention of the conditions attached to the petroleum spirit licence to make any alteration to the licensed premises that affect the approved arrangements (including the demolition of any tank on site) unless written consent has been given by the Licensing Authority.
