




## Above: Debbie Francis, Lancashire Enterprise Partnership (LEP)



# Above: Neil Jack, Blackpool Borough Council

Neil Jack was appointed as Chief Executive of Blackpool Council in September 2011. Neil, who was born and educated in Blackpool, had previously been Director of Finance and Resources at Blackpool Coastal Housing (BCH) since 2006. During this time BCH's success in a Government inspection generated nearly £50 million to improve the quality of social housing in Blackpool.

Prior to joining Blackpool Coastal Housing, Neil had previously worked for Blackpool Council in the Finance Department covering a wide variety of services.

During his six years as Chief Executive, Neil has helped steer the organisation through £118 million worth of cuts to the council's budget, while also overseeing external investment in the town of around £350 million, and acting as the landlord to some of the UK's most famous attractions: The Blackpool Tower, Winter Gardens and Sandcastle Waterpark.

The current and upcoming investment in regenerating Blackpool includes construction of Blackpool's first business district, a revamp of the resort's tramway and extension to the train station, major new conferencing facilities at the Winter Gardens plus £55 million to ensure that young children get the possible best start in life and that teenagers in the town get access to the best mental health support designed to increase their resilience. Neil has a key role in the delivery of both the Better Start and HeadStart programmes in Blackpool. He is the Chair of Executive Board for the HeadStart Programme and an Executive Board Member for the Better Start.

Work led by Neil to readdress Blackpool's housing supply has also included replacing run down social housing with new quality, family accommodation, and involves requiring poor private landlords to improve the quality of HMOs in areas of the town. An innovative £30m project for Blackpool Council to operate as a private landlord to improve run down properties in the town and enhance the current housing marketplace across the town is also under way.

As part of the council's work to create a stronger economy, Neil has also overseen huge improvements to Blackpool's tourism offer, with more than seventeen million visits to the resort being made every year, generating £1.32 billion into the town's economy and supporting 20,000 jobs. As part of Neil's role to improve Blackpool's tourism offer, he also chairs the Turning tides board, which works to improve the quality of bathing water across the North West, culminating in Blackpool being awarded the region's first Blue Flag in 2016.

Tracy Hopkins is currently CEO of Citizens Advice Blackpool and has been in this role since 2014. As a strategic leader in the Voluntary, Community, Faith and Social Enterprise Sector (VCFS), Tracy has been instrumental in developing the partnership of VCFS leaders across the Fylde Coast and Chairs the VCFS Leadership Group, working closely with partners across the Lancashire and South Cumbria Integrated Care System as part of the VCFS Alliance.

Following her time at Manchester University studying psychology, Tracy trained as a teacher in FE. This then took her on to developing training courses for adults and working within education and skills. Tracy spent 7 years a CEO of an Education Business Partnership (EBP) across Greater Manchester. Providing opportunities for young people and developing enterprise learning at a time when there was a policy focus on employability and education. During this time, Tracy worked as a consultant to the Department for Education and Skills, advising on employer engagement and helping employers implement meaningful corporate social responsibility agendas. Tracy also worked with the Specialist Schools and Academies Trust to develop education leadership and travelled to North America to share models of successful leadership with leaders from around the world, this work was instrumental in the development of academies and school business managers. Tracy's entrepreneurial skills helped her transform the EBP from a charity dependent upon grants to a social enterprise selling services to schools and colleges.

This move towards social enterprise development, saw Tracy take up the role of CEO of an exciting organization that provided accommodation, work and training to people who were street homeless. Tracy spent almost four years running this social enterprise;

developing the retail offer, opening a community café and supporting people to make the transition into independent living, employment and positive changes to their lives. During this time, Tracy also acted as Chair of a Domestic Violence charity and a trustee of Preston Community Network. Tracy worked alongside initiatives such as Big Local to support communities to find their own solutions. As an advocate of VCFS infrastructure, Tracy has contributed to a range of projects with the aim of creating a robust, sustainable VCFS that makes a positive impact on local communities.

As CEO of Citizens Advice in Blackpool, Tracy has taken the organization from a position of financial uncertainty to one of stability. Building a team who are responsive, capable and willing to innovate in order to provide the best possible service to our communities, the CAB is viewed as a strategically significant across the VCFS. Through working with funders, Tracy has secured projects to help people with debt and mental health issues and has set up Young Citizens Advice Blackpool – the first of its kind in the country. Tracy is passionate about the work of the CAB, regularly contributes to research and campaigns work at a national level emphasizing the impact this can have on the lives of seldom heard communities and individuals. Building on links with the NHS, Tracy is now working with neighbourhoods across the Fylde coast to implement Social Prescribing.
