You can make a representation against an application for a new premises licence/club certificate or a variation of an existing licence/club certificate within 28 days of the application being submitted.

For problems with premises that are already licensed - when other attempts to resolve the problem have failed - an application can be made to the council for a review of that licence.

Licences and applications can be viewed on our <u>Public Licensing Register</u>. If you require any further details about an application please <u>contact us</u>.

Representations and reviews must be relevant to one of the 4 licensing objectives:

- Prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- Protection of children from harm

### **Objections**

Any member of the public or a <u>responsible authority</u> can make a representation against an application.

A review can be submitted by any member of the public or any of the responsible authorities.

When a review has been applied for, any responsible authority or any other person can make a representation on that application within 28 days. A hearing will then be arranged within 20 working days to determine the review.
