New gambling premises licence

Premises such as:

- Casinos
- Bingo halls
- Betting shops
- Amusement arcades (known as family entertainment centres and adult gaming centres)

require a premises licence under the Gambling Act 2005 issued by Blackpool Council.

There are 3 licensing objectives under the Gambling Act which should be adhered to by licence holders:

- Preventing gambling from being a source of crime and disorder, being associated with crime or disorder or being used to support crime
- Ensuring that gambling is conducted in a fair and open way
- Protecting children and other vulnerable persons from being harmed or exploited by gambling

Apply for a new premises licence

- Download and complete the [application form \[PDF 109KB\]](#) and submit with a plan of the premises and the correct fee
- Please read the [guidance notes](#) before applying – this gives information about the application procedure including requirements for submitting plans and the fees
- You must send notice of your application to each of the [Responsible Authorities](#) using a [template form provided by the Gambling Commission](#)
- You will also need to advertise the application in the local paper and by displaying a notice on the premises

The application will be granted after 28 days if no representations are received and we then aim to issue it within 10 working days.

If representations are received a committee hearing can be held to determine the application, assuming outstanding issues can not be resolved.

An applicant for a premises licence must hold, or be in the process of applying for, an appropriate operating licence from the [Gambling Commission](#), and must have a right to occupy the premises.
