Your virtual unrestricted permit has been approved subject to the following terms and conditions.

1. Available car parks:
2. Bank Street Car Park, Bethesda Square Car Park, Bloomfield Road Car Park, Bolton Street Car Park, Bonny Street Car Park, Central Car Park, Chapel Street Car Park, Cocker Street Car Park, Cocker Square Car Park, East Topping Street, Foxhall Village Car Park, Gynn Car Park, Lonsdale Road Car Park, Lytham Road Car Park, Queen Street Car Park,, South Car Park, South Beach Car Park, South King Street Car, Park West Street Car Park
3. The council reserves the right in its absolute discretion to close car parks from time to time
4. Immediately upon the expiration of the validity of this permit the said vehicle shall be subject to the parking conditions and fees applicable within the car parks.
5. Hours of availability. Your annual unrestricted permit may be used for all hours that the permitted car parks are in operation and spaces are available
6. The council accepts no responsibility for any loss or damage to any property howsoever such loss or damage may be caused, unless such loss or damage is caused by negligence of the council or its employees
7. Vehicles must park wholly within a bay and not parked within a bay marked reserved or disabled
8. The permit remains the property of the council and is not transferable
9. If you change your Vehicle Registration number you will need to:
 1. Log on to your Permit Portal account
 2. Within the "Active Permit" section click the "View" button.
 3. Select "Change Vehicle" tab
 4. Choose "Add new vehicle"
 5. Enter your registration number and re-enter for confirmation
 6. Click the "Apply to change vehicle" button
 7. A pop-up message will appear asking you to confirm these changes
 8. Click "Yes" A message confirming your changes have been successful will be displayed. Your change of registration details will then be transmitted to civil enforcement officer handheld devices. This is done in a matter of minutes
10. Please remember that it is your responsibility to renew your permit prior to the permit expiry date
11. Refunds are not available on any unused or un-expired portion of a permit
