The Need for New Homes to 2027 (Interim Housing Consultation November 2010)

In response to all the consultation representations received at the Preferred Option stage and in light of the impending revocation of all Regional Spatial Strategies specifically the regional housing figures, Blackpool Council prepared a report setting out proposed new housing requirements for Blackpool to 2027.
