

Blackpool Town Deal Board Meeting No 8 - Agenda Item 6

1. Purpose of the report

To update the Board on progress towards delivering the Stakeholder Engagement Plan.

2. Recommendation

For the Board to note and comment on the approach.

3. Background

Previous reports to Board have provided details of the Stakeholder Engagement Plan, which is being used to direct engagement activity in a structured way in line with the Towns Fund logic model, and an initial outline of the groups to be engaged and mechanisms to be used on a scheme-by-scheme basis.

The first public engagement exercise undertaken under the Towns Fund banner in July was thematic, and sought to draw out broad ideas and suggestions on issues of interest. In light of the Heads of Terms received from Government, and using public feedback, we can now deliver a more specific exercise which asks for views on the schemes we are intending to take forward, as a precursor to more detailed engagement activity with stakeholders.

4. Next Steps

Continuing our “digital first” approach to engagement in light of continuing Covid restrictions, we will launch a further engagement exercise using the Commonplace tool in early February. This will provide information on each project alongside an opportunity to feedback views and opinions, tailored to the stage of development which the schemes have reached. A social media campaign will encourage people to participate, with results being available in March.

This will prepare the way for more detailed engagement. The engagement leads have met with scheme leads to understand the stages at which each could meaningfully undertake public engagement with the potential to impact on the form of the schemes. Work is now underway to develop a more specific action plan for engagement on schemes based on their stage of development, and which accounts for any project-specific engagement undertaken prior to the provisional award of Towns Fund monies. This is based on the table included in the Community Engagement report to the October Board meeting (reproduced at Annex A) and will be reported to the next Board meeting. The action plan will be developed with the Engagement Team, ensuring that the VCFS Leadership Group has an opportunity to review and ensure the involvement of seldom-heard communities, in addition to key stakeholder organisations. We will use the asset-mapping work undertaken by Locality to reach out to organisations and explore opportunities to connect with those excluded by digital approaches, ensuring that they add value to the investment plans by helping to realise positive outcomes around jobs and opportunities for local people, something which will be particularly important as the restrictions introduced to slow the spread of Covid are relaxed.

In addition to the support offered by the Engagement Team, it is important to note that much engagement, particularly with stakeholders, will occur on a day-to-day basis without the need for a formal process. A basic template will be used to capture this activity, which will also allow the Engagement Team to identify gaps, and to support leads in filling them:

In line with Public Sector Equality Duty requirements against each scheme and at a programme level, the engagement activity will weave in equalities as a key feature through the engagement process, ensuring that representations are sought from relevant organisations involved with, or representing, groups with protected characteristics. The Engagement Team will liaise with the Council’s Equality and Diversity Manager to ensure that this is achieved.
