

- 1. A licence can only be granted to an individual over the age of eighteen years
- **2.** It will be a condition of any licence granted that the carrying on of the business of keeping donkeys shall at no time be left in charge of any person under 16 years of age.
- 3. It will be a condition of any licence granted that no donkey will be let on hire for riding or used for carrying passengers for hire without supervision by a responsible person of the age of 16 years or over unless (in the case of a donkey let out for hire for riding) the holder of the licence is satisfied that the hirer of the donkeys is competent to ride without supervision
