3. Activity Update

3.1 Business Case Development Process

The development of business cases continues for each of the seven projects outlined in the Heads of Terms in line with HM Treasury Green Book Business Case guidance. Extensive work is ongoing to develop the schemes is underway. Activity incorporates both Council officers and retained external consultancy support via AMION Consulting who provide business case development advice and critical friend support. All 7 schemes have a Strategic Case section largely complete and activity to populate the other 4 cases (economic, financial, commercial and management) are underway.

All seven must be developed and appraised by 17th November 2021. The table below sets out the initial presentation to the TDIP and Town Deal Boards, and the dates of the proposed respective TDIP and Town Deal Board dates for scheme review. Please note that the date of completion of the Enterprise Zone business case for the TDIP has been put back a month due to a delay in project

3.2 Future Programme Management including Monitoring and Evaluation

As the Board is aware, Blackpool Council have been ring-fenced £39.5m (plus £1m fast-tracked funding) which will be formally agreed subject to the submission of seven locally appraised business cases by November 17th.

The Council will subsequently hopefully have a confirmed funding allocation by year (subject to final MHCLG sign off) and, as the accountable body is tasked with overseeing the successful delivery of these schemes to rigorous spend, monitoring and evaluation requirements.

As most of these schemes are being delivered by Council departments, the Council will in effect have to draw up funding agreements with itself and act as accountable body and delivery body. In addition, a funding agreement will be required with HMCTS for the new Courts facility funding, with Blackpool FC /Blackpool FC Trust with regards to the Revoe scheme and with Blackpool and The Fylde College with regard to the Multiversity scheme. It will then have to undertake "independent" assurance, monitoring, claims and evaluation activity with its own internal and external resource to provide assurance to government. Such a team is currently not fully in place within the Council and therefore needs resourcing.

At least every 6 months the accountable body will be required to provide government with a comprehensive set of data relating to each Town Deal project with total and forecast spend and output metrics. These returns will need to be scrutinised and signed off by the accountable body's section 151 officer. Details on the programme management and Monitoring and Evaluation requirements are attached here:-
